### Insurance

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of AUD\$5,000,000. The insurance must be valid for Tasmanian waters.

All owners/competitors who sign the Entry Form are deemed to have made a declaration that they hold such cover for their entered boat.

Competitors may be required to produce evidence of such insurance. Failure to produce evidence on request may result in the competitor's entry being withdrawn.

### Sign On

To ensure safety requirements are met, competitors are required to sign on and sign off **each** race day even if a series entry has been lodged.

## BOAT REGISTRATION, SEASON ENTRY and INDEMNITY FORM

### Indemnity

I understand that participating in the activities of the Tamar Yacht Club Inc. (hereinafter known as "TYC") will be on water and therefore I am required to be a competent swimmer and I also understand that sailing activity carries with it the inherent risk of physical injury, including serious injury such as permanent disability, paralysis and even death and in undertaking such activities I do so at my own risk.

I am also aware that it is a condition to my participation in any official or sanctioned sailing event that TYC, its officers, employees, representatives, agents, volunteers, instructors, members, or servants are absolved from all liability howsoever arising from injury or damage howsoever caused (whether fatal or otherwise) arising out of my participation in an event or in training, instruction or carriage in any vessel being used for or in connection with yacht training or racing or in any way whatsoever due to any negligent act, breach of duty, default and/or omission on the part of TYC, its respective officers, employees, representatives, agents, volunteers, instructors, members, or servants.

I am also aware that any person who participates in yacht racing, learning to sail, training or being involved with any vessel being used for or in connection with yacht racing or participating in any activity carried out by the TYC, are only allowed to do so on the distinct understanding that they do so at their own risk.

**This agreement shall be binding upon and inure to the benefit of the parties, their successors, administrators, assigns and personal representatives.**

In consideration of being allowed to participate in the activities of the Tamar Yacht Club Inc. including training and racing sessions for one season under the cover of this signed form. This does **not** include the participation in interstate regattas, or regattas held at other Tasmanian clubs.
